

# **Guide to Unemployment Benefits and Sick Time**

Due to the Coronavirus pandemic, RI Department of Labor and Training (DLT) has made changes to Unemployment Benefits and "Paid Sick Time."

## <u>Making Sense of Unemployment Insurance</u>:

There are now several ways you can qualify for unemployment benefits:

- 1. You were laid off because your place of employment closed or had to reduce its work force. When you apply, if your layoff was due to COVID-19, be sure to check that box to waive the usual seven day waiting period.
- 2. You do not qualify for the usual unemployment benefits because you are a gig worker, independent contractor, run your own business or do not have enough work quarters in your recent work history, but you are now out of work due to COVID-19.
- 3. Your workplace remains open but you had to stop working for "good cause." "Good cause" reasons related to COVID-19 include: you have tested positive for COVID-19; your doctor recommends you stay home because you are in a high-risk category; you are the sole caregiver for someone who needs care and cannot stay home alone (a very ill relative, a child home from school). *You should not quit your job unless you are sure your reason for leaving would be "good*"

cause" to qualify.

The RI Department of Labor and Training (DLT) has three separate applications on its website.

### Go to DLT



If you receive unemployment benefits you should also receive an additional \$600 per week for up to four months to supplement the usual benefits amount.

### **Making Sense of Paid "Sick Time":**

If you are sick, quarantined, or taking care of a sick family member you may also qualify for up to <u>40 hours of paid RI "Sick Time"</u> at full wage paid by your employer or up to 80 hours of <u>emergency paid sick leave under</u> federal law.



In addition, especially if your doctor takes you out of work for longer due to your own illness, you may qualify for RI Temporary Disability Insurance (TDI).

## **Click Her for TDI Application**

Individuals taking time off from work to care for an ill family member or to bond with a newborn or adopted child may qualify for Temporary Caregiver Insurance (TCI).
